The court reviewed the court investigator's report filed on 1/18/24. The report reflects there is a temporary guardianship in place in Los Angeles with a different relative, Ashley Graves. The report recommends Ms. Graves guardianship go forward in lieu of the Leary's as she has placement of Kacey. The parents had supported the guardianship with Ms. Graves. However, the parents appeared in Los Angeles County in the guardianship proceeding and indicated they no longer supported the guardianship with Ms. Graves and instead supported the Leary's guardianship. The court spoke via phone with the Judge assigned to the guardianship case in Los Angeles County and was advised the court continued the matter to a date following the hearing in this county. On 1/29/24 a copy of the Leary's objection to guardianship filed in Los Angeles County was filed with this court. The court again conferred with the Judge in Los Angeles County via email and was informed the Guardianship Petition in that case was continued to a date after the hearing in El Dorado County. The court stated at the last hearing its intent to hold the hearing on the pending petition and either grant or deny the petition. If parties intend to call any witnesses, the court intends to set a date for an evidentiary hearing. If no witnesses or other evidence is offered, the court would intend to rule on the petition.
