

**1. GUARDIANSHIP OF EZEZIEL AND LASZLO W. 24PR0131
APPOINT GUARDIAN**

A Petition to Appoint a Guardian and Petition to Appoint a Temporary Guardian were filed on 5/10/24 by the paternal grandmother Lori Martin. The court granted the Temporary Guardianship on 5/15/24. The father of the children is recently deceased which is the basis for the petition. The children had been the subject of a dependency proceeding where sole custody was granted to the father. Notice of hearing was filed with proof of service by mail to William Windam (paternal grandfather) and Nanette Ramos (maternal grandmother) on 6/5/24. A declaration of due diligence was filed regarding the mother on 5/14/24. There is no information or name provided for the maternal grandfather. The probate investigator's report was filed on 6/17/24. The report recommends the court grant the petition. The investigator spoke with the maternal grandmother and the mother. Both oppose the guardianship and state they believe the petitioner may cut off contact with the maternal family. On 6/12/24 the maternal grandmother filed an objection to the petition. The court does not have the results from the Department of Justice background check.

The court would be inclined to refer the parties to mediation to develop an expanded visitation plan for the mother including a step-up arrangement for her visits to increase over time.

A Petition to Appoint a Guardian and Petition to Appoint a Temporary Guardian were filed on 5/7/24 by the maternal grandmother Cheryl Carroll. The court denied the Temporary Guardianship on 5/15/24. The father of the children was personally served on 5/8/24. Joseph Carroll and Katrina Rood (maternal grandfather and paternal grandmother) were served by mail on 5/13/24. The mother Sarah Carroll is deceased. The paternal grandfather was listed as unknown in the petition. The report recommends the court deny the petition. The investigator spoke with the father, petitioner, other family, and non-related extended family in concluding guardianship was not needed. The Department of Justice background check is clear. The court intends to deny the Petition absent substantial evidence to rebut the information contained in the investigation report.
