

**1. GUARDIANSHIP OF AUTUMN D. PP20200032
ANNUAL REVIEW**

A petition to terminate guardianship was filed by the one of the co-guardians, Seliah Valiente requesting to terminate the guardianship as to the co-guardian, Stacey Keates on April 4, 2024. Notice was provided by mail to the co-guardian, Claudine Webb, Milcah Valiente, and Daisey Valiente. Parents were not noticed. The probate investigator filed a report on May 8, 2024. The probate investigator interviewed the minor and both guardians. The investigator concludes the guardianship is appropriate and both guardians should remain in place. Additionally, the investigator recommends the guardians be referred to mediation for a formal custody agreement.

TENTATIVE RULING # 1:
