#### 1. GUARDIANSHIP OF ERICK S. 24PR0174 APPOINT GUARDIANSHIP

A Petition to Appoint a Guardian was filed on 6/24/24 requesting Erick Sandoval Hernandez be appointed Gurdian of the minor. On 8/6/24 consent to nomination of guardianship forms were filed on behalf of both parents, the siblings Maria, Isela, and Estrella, and the two surviving grandparents. The probate investigator filed a report on 8/12/24 recommended that the court grant guardianship. There is also a request for Special Immigrant Juvenile findings as well as consents to those findings which were filed on 8/6/24. The court orders parties to appear and intends to inquire of the parties and counsel as to the manner in which the consents were obtained from the relatives and parents.

The report reflects that the ward resides with the father and the guardian equally. The guardian is in support of the termination and believes the father can care for the ward. The ward feels comfortable in the care of the father. The report supports termination of guardianship.
