1. GUARDIANSHIP OF AMBER L. PP20190013

ANNUAL STATUS HEARING

Letters of Guardianship of the person were issued on 5/29/19. The annual guardianship status report (Judicial Council for GC-251) was not filed by the guardian.

2. GUARDIANSHIP OF BRAYLNN C. 23PR0104 ANNUAL STATUS HEARING

Letters of Guardianship of the person were issued on 9/13/23. The annual guardianship status report (Judicial Council for GC-251) was not filed by the guardian.

3. GUARDIANSHIP OF GABRIEL S. PP20190217 CCRC REVIEW

The court terminated guardianship and returned custody to the father on 6/28/24. The court referred the parties to CCRC to develop a post guardianship visitation plan. The parties reached some agreements however there has been substantial dispute between the parties since the termination of guardianship. The court has read and considered the report of the mediator filed 8/22/24. The court adopts the recommendations of the mediator as the courts order for visitation and contact between the minor and the former guardian.

The report recommends the court deny the petition for guardianship. The minor is expressed he is happy and comfortable in the care if the father. While he also expressed similar feelings toward the guardians, the conclusion of the investigator is there is no basis to find the guardianship necessary.

5. GUARDIANSHIP OF LEAH N. 24PR0193 APPOINT GUARDIAN

A Petition to Appoint a Guardian and Petition to Appoint Temporary Guardian were filed on 7/12/24. The court appointed Catherine Noble Temporary Guardian on 7/31/24. The mother, Steviee Garcia and the father Ryan Niekarz signed a consent to the appointment of a guardian on 7/24/24. The petition notes the maternal grandfather and paternal grandfather are both deceased. The maternal grandmother, Sandy Carlile has not been noticed. The court has not received the guardianship investigator's report, nor has it received the background check results from the Department of Justice.

6. GUARDIANSHIP OF ROXANNA C. 23PR0078 ANNUAL STATUS HEARING

Letters of Guardianship of the person were issued on 9/13/23. The annual guardianship status report (Judicial Council for GC-251) was filed by the guardian on 8/29/24. Roxanna is 20 years old, and guardianship was established for the purpose of pursuing Special Immigrant Juvenile Status. Having read and considered the report the court finds and orders the guardianship remains necessary and shall continue.

TENTATIVE RULING # 6: GUARDIANSHIP SHALL CONTINUE. NO FURTHER HEARINGS WILL BE SET AS THE WARD WILL BE 21 IN DECEMBER NAD GUARDIANSHIP WILL TERMINATE.

7. GUARDIANSHIP OF TANNER AND CODY S. 23PR0132 ANNUAL STATUS HEARING

A petition to terminate guardianship was filed on 7/16/24 by the mother requesting termination and return of custody to her. The probate investigator filed a report on 8/12/24 stating the guardians are not in support of the petition. The report suggested the petition be granted but allow a transition. The court referred the parties to mediation to develop a step-up visitation plan with the mother but did no terminate guardianship. On 9/13/24 the mother filed a request to dismiss her petition for termination without prejudice. The court grants the request.

TENTATIVE RULING # 7: THE PETITION TO TERMINATE GUARDIANSHIP IS DISMISSED WITHOUT PREJUDICE.

8. GUARDIANSHIP OF TREVOR B. 24PR0199 APPOINT GUARDIAN

A Petition to Appoint a Guardian and Petition to Appoint Temporary Guardian were filed on 7/22/24. The court appointed Brad and Judy Barroso Temporary Guardians on 7/31/24. The father is located at North Kern State Prison, but the court does not have proof of service for the father of this hearing. The minute order reflects the father has consented to the appointment of a guardian; however, the court cannot locate a signed consent form. A declaration of due diligence was filed regarding the mother Amber Raczko on 7/29/24. While the declaration states the Petitioners were unable to locate the mother, the Petition includes an address for the mother. Additionally, the maternal grandfather was provided mail notice on 7/26/24 The investigator report was filed on 9/10/24 and recommends guardianship. The investigator was able to reach the father who confirmed his support for the petition. The investigator was not able to reach the mother. The Department of Justice background results have also been received by the court.
