

**1. GUARDIANSHIP OF ADRIANNA S. 23PR0250  
ANNUAL STATUS REVIEW**

Letters of Guardianship of the person were issued on 2/21/24. The annual guardianship status report (Judicial Council for GC-251) was filed on 2/13/25. Having read and considered the report the court finds and orders the guardianship remains necessary and shall continue.

**2. GUARDIANSHIP OF CONNOR AND WILLIAM G. 23PR0095  
APPOINT GUARDIAN OF THE ESTATE**

A Petition to Appoint Guardian of the Person was filed 9/17/24. Notice of hearing with accompanying documents was served by mail on Mother Sandra Gerrard and Grandfather Robert Hall. There are no other known relatives entitled to notice. The request is to deposit funds into a custodial IRA and waive bond. The requirements to waive bond have not been met. If the custodial IRA can be converted to a blocked account, the Court would be able to waive the bond requirement. If the total value of the assets is \$17,000 for both minors, the Court would require a single bond in the amount of \$20,000. If each minor is to receive \$17,000, the Court will require two bonds at \$20,000 each.

PETITION TO TERMINATE GUARDIANSHIP**

A Petition to Terminate Guardianship was filed 11/20/24 by Mother. Minor's Counsel filed an objection to the petition on 12/20/24. Probate investigator's report was received 1/17/25 which recommends the petition be granted. Request to Continue Hearing on Petition filed by the Guardian on 1/21/25 was granted. Notice of hearing and proof of personal service was filed by the Mother as to minors' counsel, the guardian, and the minors on 1/17/25.

Based on investigation conducted, the court would intend to grant the petition to terminate.

Petition to Appoint Temporary Guardian and Guardian were filed 11/7/24. On 11/13/24 Brittany Alonzo was appointed temporary guardian of the minor. The court dispensed with notice to the paternal grandfather. The mother of the child is deceased. The father signed a consent to guardianship on 11/12/24. Grandparents Teri Erich, Richard Price and Gloria Alvarez all signed consents to appoint guardian. The Petitioner does not have the name of the paternal grandfather. An investigative report was filed 1/28/25. The investigator recommends the guardianship be granted.
