#### 4. GUARDIANSHIP OF SEBASTIAN Q., 25PR0007

#### **Petition to Appoint Guardians**

On February 7, 2025, the court issued letters of temporary guardianship of the person.

As it relates to the instant petition to appoint guardians, petitioners filed the mandated (1) Child Information Attachment form for the Probate Guardianship petition (Form CF-210(CA)); (2) Duties of Guardian and Acknowledgement of Receipt form (Form GC-248); (3) Confidential Guardian Screening Form (Form GC-212); (4) Declaration Under UCCJEA (Form FL-105/GC-120); (5) Consent of Proposed Guardian (Form GC-211); and (6) Parental Notification of Indian Status (Form ICWA-020).

#### **Notice**

There is no proof of service in the court's file establishing that the minor's mother and father were *personally* served with notice of the hearing and a copy of the guardianship petition. (Prob. Code § 1511, subd. (b).) There is a Notice of Hearing filed February 7, 2025, that indicates mother was served by mail, rather than the required personal service. Thus, service on mother was insufficient. Further, paragraph 2 of the Child Information Attachment (Form CF-210(CA)) does not identify the minor's father or his address; rather, it states, "N/A." However, other paperwork in the file names Brian Quintanilla as the minor's father.

#### Reports

To date, the court investigator's report is not in the court's file.

CLETS reports concerning petitioners and the mother were submitted to the court.
